1 Pursuant to the *Stipulation for Entry of Judgment in Interpleader* (the
2 “Stipulation”) made among Plaintiff Minnesota Life Insurance Company (“Minnesota
3 Life”) and Defendants Rafia Farook, Saira Khan, and the United States of America,
4 and with good cause appearing therefore, it is hereby ordered, adjudged and decreed
5 that:

6 1. Minnesota Life filed its Complaint in Interpleader in good faith on June
7 8, 2016 and this action is proper cause for interpleader;

8
9 2. By reason of the death of Syed Rizwan Farook (the “Insured”) on or
10 about December 2, 2015, the sum of Two Hundred Seventy-Five Thousand Dollars
11 and No Cents (\$275,000.00) (hereinafter “the Death Benefit”) became payable under
12 Minnesota Life’s group life insurance policy number 33772-G issued to San
13 Bernardino County (the “Policy”);

14
15 3. Defendants Rafia Farook, Saira Khan, and the United States of America
16 each assert or may assert some claim to the Death Benefit and that, to date, no other
17 person or entity has made a claim to the Death Benefit;

18
19 4. Having deposited the Death Benefit, plus interest, in the total amount of
20 Two Hundred Eighty Thousand Seven Hundred Fifty-Six Dollars and Seventeen
21 Cents (\$280,756.17) with the Clerk of this Court on June 10, 2016, Minnesota Life is
22 hereby released, discharged, and acquitted of and from any liability of any kind or
23 nature whatsoever under the Policy;

25 5. Minnesota Life waives its right to recover attorney’s fees and costs in
26 connection with this action;

1 6. The remaining parties, Rafia Farook, Saira Khan, and the United States
2 of America, will litigate the dispute among themselves; and Minnesota Life is not a
3 necessary party to such litigation; and

5 7. Minnesota Life is granted judgment of interpleader.
